Bid Location: Brunswick County Schools Operations, 199 Sessions Drive NE, Bolivia, NC 28422. Bids must be clearly labeled and placed in Bid Box at Front Door.

The following items supplement, change, delete or add to the Construction Documents as though repeated in full therein. All general conditions, special conditions, etc., as originally specified shall apply to these items.

#### 1. CLARIFICATIONS / ADDITIONAL INFORMATION

a. Pricing and bidding notes on architectural drawings have been updated to reflect the previously issued Addendum No. 4, Item 3.g. "Revised Architectural drawing notes regarding installation shall be released in the next addendum." Revised drawings are attached to the end of this addendum.

#### 2. REQUESTS FOR INFORMATION

The following questions were asked and answered:

- a. Should the cabinets underneath the fume hoods be included with the price of the fume hoods, or should these cabinets be included with the casework price that we provide directly to you?
   <u>Response</u>: Fume hood is benchtop unit per Section 115313 Laboratory Fume Hoods.
   Casework under Fume Hoods to be provided by casework vendor.
- b. Paragraph 2.6.D.4, of Section 123553 Laboratory Casework, seems to have the Service Fixtures (primarily water faucets with vacuum breakers) in the casework vendor scope of work. The Plumbing drawings seem to have the fixtures in the Plumber's scope of work. Who is supposed to provide the water faucets and emergency shower/eyewash units?

  Response: Plumbing scope to include fixtures and eyewash/ shower units.
- c. The A plan sheets call out for the sinks to be provided by the casework vendor. The sinks are also listed on the P plan sheets in the fixture schedule. Typically, they would be provided by the casework vendor. Please advise.

**Response**: Sinks are to be provided by the casework vendor.

d. There are roof curbs to be flashed in at NBHS and SBHS. Are the roofs bonded at either school?

**Response**: Roofs at NBHS and SBHS are not bonded.

e. There are notes for items throughout that call for items to be relocated or furnished new. Do we base the new items off the matrix?

**Response**: Keynote #24 has been added to indicate new whiteboards. Keynote #12 has been revised to indicate only relocated smartboards, whiteboards and tackboards. Revised Drawings and Scope Matrix are attached to the end of this addendum.

- f. There are (2) refrigerators called out in the specs. A French door model and an undercounter model. Which model do we quote?
  - **Response**: Provide undercounter refrigerators.
- g. There are 2 new Dishwashers shown on the drawings, 2 for NBHS, and 2 for SBHS. Who is responsible for those?
  - **Response**: General contractor to provide dishwashers.
- h. Who is responsible for the safety signage shown on sheet A3.01? It is mentioned in paragraph 2.1.D in Section 115300 Laboratory Equipment.

**Response**: General contractor to provide safety signage referenced on sheet A3.01 and Specification Section 115300.








SOUTH BRUNSWICK HIGH SCHOOL -400 BUILDING FLOOR PLAN




















4 TEACHER STATION (BACK)




5 ROOM 410 - NORTH ELEVATION




6 ROOM 410 - EAST ELEVATION




7 ROOM 410 - SOUTH ELEVATION




8 PREP 410A - NORTH ELEVATION




9 PREP 410A - EAST ELEVATION


ROOM B05 - NORTH ELEVATION (OPP)

















PREP 403A - EAST ELEVATION




4 ROOM 526 - SOUTH ELEVATION


8 ROOM 403 - NORTH ELEVATION






